- More trees (90 hedge saplings), for the boundaries were supplied by The Woodland Trust in November. My thanks to Val and Dave Burlingham and any others who planted them.
- High-viz jackets for use at events. Sarah to look at purchasing a dozen. I should be able to get some from Lions which are surplus to requirements.
